The patient must sign this form and provide authorization on page 2 via the "Adult Proxy Authorization for Access to Medical Information" form. The patient's account will be accessed through your (the proxy's) OSF MyChart account. Completion of this form is required before we can establish an OSF MyChart account for you and access to the patient's information. Return forms to your healthcare provider.

## OSF MyChart Terms and Agreement

- I understand that OSF Healthcare System has been contracted by my provider to provide OSF MyChart.
- I understand that OSF MyChart is intended as a secure online source of confidential medical information. If I share my OSF MyChart ID and password with another person, that person may be able to view my or my child's health information, and health information about someone who has authorized me as an OSF MyChart proxy.
- I agree that it is my responsibility to select a confidential password, to maintain my password in a secure manner, and to change my password if I believe it may have been compromised in any way.
- I understand that OSF MyChart contains selected, limited medical information from a patient's medical record and that OSF MyChart does not reflect the complete contents of the medical record. I also understand that a paper copy of a patient's complete medical record may be requested from the applicable provider.
- I understand that my activities within OSF MyChart may be tracked by computer audit and that entries I make may become part of the patient's medical record.
- I understand that OSF Healthcare System has been contracted to provide me with access to OSF MyChart and that OSF Healthcare System and/or my physician has the right to deactivate access to OSF MyChart at any time for any reason. I understand that use of OSF MyChart is voluntary and I am not required to use OSF MyChart or to authorize an OSF MyChart proxy.

# Adult Proxy Authorization for Access to Medical Information

This form is an authorization that will allow access to your medical information available in OSF MyChart to your designated adult proxy. Please read it carefully.

This form should be completed by the patient who is authorizing another adult to access medical information in his or her OSF MyChart account. It must accompany the Adult Proxy Form, which provides the name and information of the individual who the patient is authorizing to access their OSF MyChart account as a proxy.

This person is my designated OSF MyChart proxy. I authorize access of the health information contained in my OSF MyChart account to my OSF MyChart proxy. I understand that the medical information in OSF MyChart is obtained from my electronic medical record and may include sensitive medical information including information related to mental health, alcohol or drug abuse conditions, developmental disabilities, etc. I authorize access to all currently existing and future information contained in my OSF MyChart account to my designated proxy.

I understand and agree that my proxy is my designated personal representative who may communicate freely with, and receive communication from, my physician and his/ her office staff on my behalf.

I understand that once information has been accessed, it potentially may be disclosed by the proxy. Information disclosed by your proxy may not be covered by federal privacy protections.

Participation in OSF MyChart and designating an OSF MyChart proxy is completely voluntary. I understand that I am not required to designate an OSF MyChart proxy and I am not required to provide this authorization. I also understand that my provider does not condition any of my health care treatment, payment or other services on whether I provide this authorization. However, I also understand that if I do not provide authorization, my provider is not permitted to provide access to my OSF MyChart account to my designated proxy.

This authorization will not expire until my death unless I revoke this authorization, or the designated proxy resigns their position. Either person may revoke access at any time. I understand that if I revoke this authorization, my designated proxy's access to my OSF MyChart account will end. I also understand my revocation will not affect access to any information that was made prior to processing the revocation request; the change will take several days to process.
